# Action Time:

10-20 minutes for synthetic paints.30-60 minutes for polyurethane paints.4-10 hours for polyester paints, epoxy and oven-cured enamels.

# Use / Applications:

The product is effective on synthetic paints even with several layers, oil paints, nitrocellulose, acrylic, polyesters, two-component polyurethane, cold and oven enamels, water-based paints and plastics, fillers, adhesives for carpets and parquet.

Also indicated in the nautical sector, furniture restoration, construction and stone application.

# How to use:

Mix the product after opening the container.

Apply a generous layer of paint remover with brush or a spatula. Wait for the product to penetrate completely, then remove everything with a spatula or a rag.

It has a density that allows a perfect spreading even on vertical surfaces and the coloring facilitates a homogeneous application.

## Warning:

For applications on tough paints and with long action times, it is advisable to apply a cellophane film over the product, especially on hot weather conditions.

Avoid use on plastics, hot surfaces or exposed to the sunlight.

In the case of use on wood, being a natural and variable support, it is advisable to carry out an application test, in a small area that is not very visible, to avoid undesired effects.

#### Product not suitable for use in the body shop.

Do not shake before use. Open the cap carefully, as the product could discharge violently if under pressure; then cover the mouthpiece with a rag and pull the opening ring slowly, until it is vented, keeping the container away from the face.

#### Wear protective goggles and gloves during application.

keep the container tightly closed, away from any heat source and in a cool and dry place.

The waste produced by the use of the remover should always be considered as hazardous and disposed of through specialized companies.
